3.1 PRESENTATION OF FINANCIAL STATEMENTS AND HONORARY TREASURER'S REPORT

Michael Kalimnios – Treasurer presented the prepared financial statements for 1 July 2020 to 30 June 2021

On behalf of the Board, I am pleased to present the financial report for the year ended 30 June 2021. This year saw a substantial increase in our surplus compared to last years' result. We have managed to achieve a surplus of \$506,313 (year ended 30 June 2020: surplus of \$245,212). He thanked the Branch Treasurers for their continuous input into the finances of the College and Dionne Barton for her fantastic process and reporting of our finances.

SDJA Specialists NSW were appointed the College's Auditors for 2021-2022 year.

Catherine Chaffey instructed members to vote on the resolution via the online pole. She mentioned that she had received over 10 proxy votes.

RESOLUTION **Constitution** - The Members resolve to adopt the amended Constitution as per the marked-up copy at Appendix 1 of the Agenda papers and authorize the Board to prepare an updated formatting of the Constitution to correct layout errors, ensure consistency of clause numbering and cross referencing to correct typographical errors
