Te Whatu Ora Leadership Institute RFP

Over the summer a group of ACHSM – Aotearoa Branch Council members worked in partnership with ACHSM to submit a response to the Te Whatu Ora RFP for the establishment of a Leadership Institute. The RFP asked for responses for 5 different programme streams. As a College, we responded to Programme 4: Leadership Talent Programme – Fast Stream for those with >5 years' experience, and Programme 5: Leadership Talent Programme for up and coming top executive leaders. We await feedback from the RFP assessment panel as to whether we have been taken to the next stage of the process. A response is expected before the end of April.
